- Actor II is able to use the knowledge, skills and tools of Theatre and Film Actor to contribute effectively to the theatre and film production and rehearsal process, and to perform acting and group acting tasks in accordance with the director's instructions with creative intent, at an appropriate technical level and in compliance with the rules of safety at work and accident prevention related to his/her activity.;
- know and respect the rules and conditions of stage and film production;
- comply with the rules of safety at work and accident prevention related to theatre and film production;
- apply analytical skills, theoretical knowledge and role-building techniques in the creative process;
- record the director's instructions and follow them to perform stage and film roles;
- act as an individual, episode or group actor in theatre and film;
- fully perform the theatre and film rehearsal tasks assigned to him/her, according to his/her training and knowledge, both in internal (theatre, studio) and external (e.g. guest performance, performance outside the official seat, occasional stage, etc.) locations;
- perform stage and film roles in the aesthetic form defined during the rehearsal process, in a specific style of acting, with the appropriate intensity and technical quality during stage performances and filming;
- know the strategies of text interpretation and analysis and the methodology of their application;
- know the methods of speech analysis, techniques of speech development and improvement;
- understand and know the techniques of dealing with everyday life situations, the methodology of presenting dramatic scenes in a meaningful and high-quality way, the techniques of role building on stage and in film;
- have a precise professional knowledge of the technical basics of stage singing and the characteristics of songs of different moods and genres (operetta, musical, chanson, dance song, couplet, etc.);
- understand and know the techniques for the use of the body for stage expression, the methodology for learning the choreography used, the basic elements of the movement forms and styles of ballet, jazz ballet and folk dance;
- have an overview of the major eras of theatre, film and drama, and be familiar with its major dramatic works.
