- Has the ability to determine the client's physical and fitness condition, to set realistic training objectives based on the client's current condition, and to assign appropriate training equipment and methods to achieve the objectives;
- Confirms the client's motivation, provides accurate feedback on the effectiveness of the training, and suggests changes to the training programme if necessary;
- Plans and leads training sessions taking into account the health and functional needs of the developing body;
- Plans and conducts extra-curricular sessions in educational and training institutions to develop motor skills, correcting assistance and technical errors;
- Helps clients, through verbal consultation, written questionnaires or various video techniques, to find an individual and/or collective recreational exercise programme suited to their interests, fitness level, body type and physical condition;
- Provides information to clients on the accident prevention and safety regulations and services of the dance training facilities, and on the proper use of the equipment;
- Observes and complies with the accident prevention and safety regulations for the use of the facility and sports equipment;
- Provides first aid when necessary in accordance with the rules of the profession.
