- Prepares a report on the discovery of deficiencies experienced during incidents with the use of fire safety, industrial safety and civil protection inspection methods;
- Applies fire safety, accident prevention, health and environmental protection tools, appropriate methods and relevant procedures during the elimination of incidents;
- Performs civil protection tasks, applies notification and standby rules;
- Analyzes industrial safety risk factors and corresponds with the units performing special tasks during the intervention.
