3. PROFILE OF SKILLS AND COMPETENCES

- Analyzes the fire safety obligations and status of the business organisation and facility in context, reports on this both orally and in writing, makes suggestions for improving deficiencies and directions for development;
- Prepares and professionally supports managerial decisions and fire safety measures, oversees the work of people involved in fire safety tasks;
- Organizes the fire safety measures of highly dangerous factory from a fire safety point of view, creates and operates a fire safety organisation and a system of fire safety representatives when necessary;
- Prepares and continuously updates fire safety regulations, the fire alarm plan, and other regulatory documents and plans related to fire safety; ensures that concerned parties familiarise them in the necessary scope and extent. Contributes to the implementation of fire safety considerations in the internal regulation and coordination activities of other specialist areas;
- Performs organisational and record-keeping tasks related to fire safety education and professional examinations, compiles the topics of fire safety education, and conducts fire safety training;
- Contributes to the conclusion, modification, control and certification of fire safety-related service contracts;
- As a specialist of the host facility, contributes to the preparation, organisation, implementation and evaluation of exercises to be held by fire departments;
- Manages fire safety records at a high level and maintains the necessary documents, arranges for keeping them up-to-date and continuously available;
- In instances required by law, initiates the establishment of a facility-based fire department and professionally supports its establishment and operation;
- Evaluates and professionally supports, in terms of fire safety, the planning, execution and definition of the rules of use, and safe commissioning of developments, investments, and conversions;
- Supervises and arranges for the supervision of the condition of fire safety equipment, tools and equipment, makes preparations for their professional and safe use. Assesses the need for improvements and replacements. Arranges for the fulfillment of inspection, review, maintenance and registration obligations;
- Liaises with fire safety authorities and professionally supports their client, particularly in the submission of applications, the fulfillment of reporting and data provision obligations, as well as in tasks related to official decisions;
- In the event of a fire, manages priority fire alarm, firefighting and rescue tasks, fulfills reporting obligations, and as a local specialist supports the activities of the fire chief and the fire investigator;
- Informs organisational leaders about changes in fire safety-related legislation and regulations, as well as the professional and technical developments in the field of fire safety, formulates proposals for the necessary measures and opportunities for development.

Part 1 of the examination: Within the framework of the examination, the candidate comprehensively evaluates the fire safety status of a facility that requires the expertise of a person with a higher level fire safety qualification pursuant to legal requirements, based on the task description compiled by the examination organiser, and prepares a written report on their findings, the necessary measures and possible direction of developments

Part 2 of the examination: As an oral supplement to the examination paper, the examinee explains their findings, supports them professionally, defends them, and gives an account of their firefighting and fire safety management and technical preparation related to the task of the examination paper
