3. PROFILE OF SKILLS AND COMPETENCES

- Informs customers verbally and in writing of any findings made in the course of the chimney sweeping industry activities;
- Assessing the risks of fire, occupational health and safety and environmental protection, takes action to eliminate the hazard in the event of an accident, and provides professional first aid if necessary;
- Carries out preventive fire, environmental protection and energy efficiency activities;
- Reads architectural and building engineering plans, as well as technical documentation, and interprets technical situations, under the professional guidance of a master chimney sweeper and taking into account the information required to perform his/her duties;
- Carries out the full range of technical tasks related to the controlling, cleaning and technical supervising of flue gas drains (serial work activity). Carries out technical supervision of flue gas drains under the supervision of a master chimney sweeper;
- Carries out the chimney sweeping industrial and necessary combustion engineering measurements;
- Performs the documentation of the chimney sweeping industry activity;
- Records and processes data in a target-specific electronic system. Uses word processing and spreadsheet managing software, mail systems, Internet on a basic level;
- Performs the cleaning of the combustion equipment on the flue gas and the charge side;
- Visually inspects and, if necessary, cleans the ventilation systems.

PROJECT EXERCISES

Exam part 1: Carrying out serial work. Content: - control, cleaning as required, and technical supervision of a flue gas drain in use, checking the adequacy of the combustion air supply, checking the carbon monoxide content of the flue gas, fault detection with visual inspection and fault interpretation, checking for density, demonstration and use of the technological tools, administration of the activity, providing information to the customer, professional discussion in line with the examination task
Part 2: Cleaning of ventilation system. Content: - demonstration and use of cleaning equipment, - professional discussion in line with the examination task
Part 3: Combustion technology measurement and, if necessary, cleaning of combustion equipment. Content: combustion technology measurement, - demonstration and use of cleaning equipment, - professional discussion in line with the examination task
