- prepares pest control (prevention and extermination) plans, programmes and strategies;

- selects, procures, safely transports and stores pesticides, and documents their use;
- uses and applies pest control tools;
- knows the tasks that can only be carried out under the professional supervision of a sanitary gas operator and the tasks that can only be carried out by a sanitary gas operator;
- knows the rules, techniques and methods of first aid at work and recognises the need for medical emergency assistance;
- is familiar with the health and safety, fire protection and environmental protection regulations and tasks related to his or her activity;
- identifies the hazardous waste generated during his or her activities.
