- the occupational health care nurse – in close cooperation with the occupational health physician – is involved in tasks related to the optimal workload of workers and the monitoring of their health;
- covers all three levels of preventative measures within their area of competence;
- recognises risks, pathological factors and accident hazards at the workplace, and takes the necessary action in accordance with their level of competence;
- organises and assists in fitness tests, health screening and the preventative measures of infectious diseases;
- carries out blood pressure, weight and height measurements, BMI index calculation, visual acuity examinations and colour vision tests, screening audiometric tests, respiratory function tests, Doppler tests, ECG and laboratory tests, health assessments;
- assists in the handling of specific health situations in cases of pregnancy or breastfeeding, and helps both younger and elderly employees;
- monitors working conditions in the workplace and recognises any breaches of hygiene, occupational health and safety, chemical, food safety and epidemiological regulations;
- participates in the examination, treatment and care of the individuals suffering from occupational diseases, and in the investigation and reporting of such diseases;
- facilitates the implementation of occupational rehabilitation for individuals with reduced working capacity, and to employability assessments;
- provides care for workers with chronic diseases;
- provides advice on the use of personal protective equipment;
- facilitates immunisation at the workplace;
- provides care in case of accidents and other occupational incidents, organises first-aid training for the employees and monitors first-aid equipment at the workplace in line with their qualifications;
- organises health promotion programmes with particular focus on health risk factors (e.g. smoking, alcohol, drugs, poor diet, stress);
- besides maintaining contact with employees, the occupational health care nurse liaises with employers, occupational safety and health professionals, interest groups, professional associations and organisations and representatives of other health-related fields;
- manages the operation system used in occupational health care;
- complies with fire, occupational health and safety, accident prevention and general health and safety regulations;
- continuously develops their competence, attends training courses and places great emphasis on self-education;
- participates in the quality assurance activities of the occupational health services.

The assessment of professional competence as set out in Section 4 (3)a of Decree 33/1998 (VI. 24.) NM of the Ministry of Social Welfare on the medical examination and assessment of fitness for employment, occupational and personal hygiene.
