3. PROFILE OF SKILLS AND COMPETENCES

- The adult intensive care nurse carries out care and treatment of critically ill patients and patients requiring long-term intensive care in the field of intensive care;
- Participates in the prevention of acute life-threatening conditions, in the stabilisation of the patient's condition, for which he or she has special physiological, pathophysiological, clinical, diagnostic, therapeutic and nursing knowledge, and is able to independently perform nursing tasks related to conditions requiring intensive care;
- Assesses the needs of the patient requiring intensive care, plans and implements the patient's care and nursing, evaluates its effectiveness;
- Recognises conditions requiring intensive care, based on his or her preparedness, manual skills and characteristics;
- Carries out his or her work in cooperation with the members of the health care team, patients and relatives, in compliance with the ethical and legal requirements arising from the special situation of patients, and in a responsible manner, practising his or her work as a vocation;
- In the course of his or her work, he or she applies the special hygiene rules for the care of critically ill patients, as well as the rules of asepsis and antisepsis. Selects the most appropriate environment for the care of the infectious patient, and the prevention of the transmission of infection, ensuring the safety of the patient and the caregivers;
- Performs BLS, IHBLS, uses AED, defibrillator, participates in ALS;
- Assists in the care of patients with PTX, in establishing and maintaining chest suction;
- Assists in endotracheal intubation/extubation/surgical airway management;
- Performs non-invasive, invasive monitoring, uses procedures based on thermodilution. Observes and interprets extracorporeal circulation, documents observed parameters. Performs special ECG examination, analyses according to competence;
- Performs arterial puncture, inserts arterial cannula, take arterial blood samples. Performs astrup, bedside tests, evaluates and documents results;
- Observes neurological symptoms, uses intracranial pressure monitor, measures ICP;
- Cares for patients with acute brain injury, post-operative patients, seriously injured patients, poisoned patients, burnt and cold patients, performs specialist nursing tasks;
- Continuously improves his or her professional knowledge, attends professional conferences and training courses.
