3. PROFILE OF SKILLS AND COMPETENCES

- During work, he or she uses the names of the used plants in scientific forms, both in Latin and in Hungarian;
- Selects and maintains appropriate tools and equipment for work;
- Prepares his or her products in accordance with the rules and laws of floristry, using the experience of the oustanding players in the profession, combined with modern techniques;
- Professionally prepares and cleans up live plant parts, accessories and supplements for further use. Uses procedures necessary to meet the needs of plants and maximise their lives;
- Creates flower bouquets, stitched flower arrangements, wreaths, memorial ornaments, dry and silk flower arrangements, gift wrappings, plant arrangements, spatial decorations, seasonal decorations;
- Designs and prepares floral arrangements for occasional (wedding, memorial) and other events. Calculates the quantity of materials and prepares a quotation. Takes into account the personality and needs of the customer when preparing the offer and the decoration;
- Uses the possibilities offered by social media to promote his or her business. Creates and manages promotional photos, posts and entries;
- Gives advice on the care of live plants and their needs. Takes into account the current season when planning the supply of live plants;
- Plans daily, weekly and monthly workflows. Is able to prepare weekly, monthly work schedules and leave plans in accordance with the legislation;
- Prepares plans to promote sales according to different sales periods;
- Uses the cash register, issues strict accounting vouchers, receipts and invoices manually or online;
- Orders goods, compiles orders, prepares material calculations. Liaises with suppliers. Receives and evaluates offers electronically or offline. Monitors prices and quality. Selects suppliers taking into account prices, quality and customer needs;
- Applies fire and accident prevention and safety rules.
