- Performs specific daily care and feeding tasks for the given animal;
- Performs machine milking according to the hygiene standards, carries out cleaning, maintenance;
- Prepares the farrowing crates and the necessary tools;
- Carries out the ground works, operates the machinery, prepares the seedbed;
- Cares for seed storage, prepares the seeds for sowing;
- Harvests the crop, transports it to a storing place, measures its moisture content and purity;
- Performs protection against weed damage;
- Cares for vegetable plants (cares for seedlings, carries out sowing, needling, watering), collects, cleans, packs, sells;
- Operates electric garden machinery and engines, carries out daily maintenance of agricultural machinery before setting off.
