- demolish wall constructions based on a demolition plan, create subsequent openings and lintels in wall constructions;
- determine the quantity of materials required for the construction of wall structures based on a field survey and/or plan documentation;
- use personal protective equipment;
- know the rules of work, accident, fire and environmental protection applicable to bricklaying and follow them consciously.
