The group performance (a folk dance, which is also traditionally a group dance form) is followed by an individual performance. Next, there are three types of tasks: a dance type performed while singing, the next two are individual dance improvisations from the dance set of a dialect, performed in couples and solo
A stage examination performance in costume, to live music, consisting of the following parts: the folk dance choreographies must include a dance of at least two microregions per dialect of the Danube, Tisza and Transylvanian dance dialects. The candidates will perform a solo, small and large group performance of dances from at least six microregions, demonstrating their choreographic and improvisational skills.
