- make, repair, renovate and remove the facework, plinth panel, stair-tread covering and paving;
- draw up a tile layout plan on the basis of technical documentation, carry out calculations relating to the quantity of materials and check whether specialist pre-tiling works have been performed in accordance with the technical design;
- handle, store and transport the cladding materials properly and in accordance with the relevant regulations, work the materials using small machines, install and apply them in an aesthetic manner;
- properly prepare different surfaces for flooring and tiling;
- apply tiling grout and refinish the cladding;
- transport and store the waste generated in accordance with labour safety, work safety and environmental regulations.
