- Assess, examine, diagnose and document in written form the characteristics of new and renovated exterior and interior surfaces;
- Carry out necessary surface preparation and surface treatment tasks depending on the results of the assessments;
- Determine technological sequence based on the results of surface assessments;
- Select, store, prepare and mix the required materials as required by the technology applied;
- Select and professionally apply the tools, equipment and machinery required for the work area;
- Measure, mark and examine surfaces. Prevent unpainted surfaces from being damaged;
- Have the ability to identify and professionally build the complete coating system for each of the required work processes;
- In the case of colouring, adjust the required colour shade and consistency, perform test painting;
- Consider, design and describe the decoration options for the prepared surface;
- Communicate with the client, outline the colour scheme and decoration options;
- Prepare simple and/or more ornate surface decoration;
- Evaluate and rate the work according to the requirements;
- Provide a suitable, professional environment and conditions during the work;
- Carry out the necessary follow-up work (cleaning of tools, equipment, work area; storage of materials; waste management);
- Hand over work area, prepare invoices.
