- cooperate as a member of the rehabilitation team with the doctor, the physiotherapist and the physiotherapy assistant in order to help patients recover;
- perform Swedish massage, refreshing aromatherapy massage, wellness massage, therapeutic massage and physiotherapy treatments in thermal baths, hotels, wellness and fitness centers;
- carry out his/her work showing great empathy and tolerance towards patients and exhibiting ethical behaviour.
