- use jewellery reference books to decipher maker's marks and hallmarks and tables for the description and classification of gemstones;
- professionally name and describe the characteristics and condition of the object on sale in order to fill out the invoices, prepare auction catalogues and communicate authentically;
- describe jewellery, ornaments and main gemstones, estimate their value and determine the price charged for them in various commercial transactions.
