- carry out the prescribed follow-up treatments after medical treatments and surgeries, administer the necessary medicines;
- monitor the health and vital signs of animals entrusted to them, checking the necessary parameters from time to time;
- discharge their duties, taking into account animal welfare considerations at all times;
- recognise the most typical diseases of pets and domestic animals, know their anatomy as well as the basic procedures and tools required to treat them;
- assist the veterinary surgeon in performing official food hygiene and disease control tasks and measures;
- perform administrative tasks related to their work in possession of adequate computer technology knowledge.
