- prepare the tools, machines and equipment at the polishing garage or plant for work and ensure the continuous operation and cleanliness of the equipment used by carrying out regular and periodic maintenance work or arranging for such work to be carried out;
- understand the quality and technical requirements of upstream and downstream operations;
- look for marks and defects in polished surfaces and, by taking into consideration technical aspects and cost-effectiveness, decide on whether repairs are feasible and carry out such repairs;
- assess and plan the polishing work to be carried out, provide a quotation for the work in question, taking into account such aspects as surface quality, function, cost-effectiveness and polishability, perform the polishing work, evaluate the quality of the surface and hand over the vehicle to the customer.
