### Entry requirements:

- Educational prerequisite: secondary school-leaving certificate; in the case of simultaneous studies in educational programmes, elementary school qualification attested by a certificate of completion of Year 8
- Vocational prerequisite: no previous vocational education and training is required for the programme, but during the written practical vocational aptitude test, the VET institution assesses and evaluates whether the candidate has appropriate theoretical knowledge in the field of the art of music and practical instrumental (singing) knowledge, and whether they are well-acquainted with the music genre concerned
