- collaborate with practitioners of other professions in delivering complex care for people with dementia;
- recognise the early signs and the behavioural and psychological symptoms of dementia (BPSD symptoms) as well as altered behaviour;
- use effective tools of communication in care, such as helping, showing empathy, empowering and treating individuals as adults, encouraging and treating them with respect;
- recognise disturbances in everyday activities;
- work in partnership with the family of the individuals cared for;
- intervene effectively within their level of competence during prehospital emergencies;
- recognise the signs of abuse to which individuals with dementia are subject and propose ways to prevent it;
- understand and support the spiritual needs of people with dementia;
- use person-centred care methods in their care activities;
- organise and conduct group sessions, using the exercises learned;
- put forward suggestions for making the home and institutional care environment of people with dementia safe;
- observe the ethical standards learned.
