Task to be performed in open water or in a pool meeting the requirements – 50 metres of freestyle swimming in 50 seconds

Task to be performed in open water or in a pool meeting the requirements -40 metres of mixed swimming (breaststroke and freestyle) in 8 minutes

Task to be performed in open water or in a pool meeting the requirements – 200 metres of freestyle swimming with clothing in 7 minutes

Task to be performed in open water or in a pool meeting the requirements - demonstration of water dives

Task to be performed in open water – underwater swim of 20 metres

Task to be performed in open water – finding and retrieving a lifeguard training dummy from a depth of 2–3 metres in a 4x4-metre area marked with buoys after a surface swim of 20 metres in 3 minutes

 $Task\ to\ be\ performed\ in\ open\ water-pulling\ out\ a\ lifeguard\ training\ dummy\ from\ the\ water$ 

Task to be performed in open water - 200 metres of running, 200 metres of swimming, 200 metres of running in 7 minutes

Task to be performed in open water – demonstration of a simulated rescue from a distance of 10 metres, using life-saving equipment

Task to be performed in open water – demonstration of a combined rescue task

Task to be performed in open water – demonstration of the administration of first aid in emergencies
