3. PROFILE OF SKILLS AND COMPETENCES

- carry out and document environment safety tree risk assessments;
- analyse the targets at risk in the event of a tree fall or uprooting and the condition of the tree;
- improve the living conditions of trees;

europass

- carry out soil improvement, where necessary, soil replacement, nutrient replenishment, irrigation and drainage tasks;
- ensure the protection of trees at construction sites;
- carry out root treatment, root pruning and root sealing tasks and protect the exposed roots;
- perform tree surgeries;
- treat bark injuries, damages to the phloem layer of the tissue, cracks and wounds as well as hollows;
- prune twigs and branches in due course and with appropriate frequency, disinfect pruning tools and handle cut surfaces;
- prevent trees from leaning, deal with fallen trees, carry out static reinforcement on the trunk and crown without damaging the tree and causing compression, check reinforcements;
- carry out tree protection measures including the protection of the whole surrounding area of the tree or its static protection zone and its trunk.
