- mobilise and transport patients according to their condition;
- follow the rules for safe working practices and handle the necessary tools professionally;
- keep patients' rights in mind in the course of their work, and assist patients in asserting their rights when necessary;
- manage the required medical documentation, comply with data management and data protection rules;
- use IT tools at user level.
