3. PROFILE OF SKILLS AND COMPETENCES

- deal with the mass manufacturing of womenswear in various sizes as well as of other products such as bed linen, curtains, home textiles, adjust them and make alterations based on technical documentation;
- his/her work is characterised by creativity, he/she has a wide range of knowledge of the fashion industry, has excellent manual skills, is punctual, has a good eye for details, is interested in digitalisation, is independent but is also able to work in a team;
- working as an employee or entrepreneur, the men's tailor makes womenswear with series and showroom techniques and manages orders;
- carry out preparation, sewing and finalising operations in operation breakdown, in the case of mass manufacturing;
- select the machines, the ironing equipment and the press machine necessary for manufacturing and operate them in a safe manner;
- design sewing patterns, model the garments in size M or tailor them to one's individual body shape either by hand or by using specialised garment editing programmes;
- after the design, calculate how much material is needed for the garments and carry out tailoring and gluing tasks;
- in the case of custom-made garments, manage the orders; prepare price estimates, carry out custom-made tailoring tasks and fittings, tailor the garments to one's needs after the fittings and finish the womenswear;
- issue the invoice of the service performed and deliver the ordered products;
- communicate at a basic level in a foreign language as well as present products and read professional publications in a foreign language.
