- offers adventure and establishes behaviour and situation management patterns adapted to infants' needs during his/her educational activity and encourages independent experimentation and creativity;
- involves appropriate professionals in the educational process in the event he/she encounters developmental or behavioural problems;
- keeps electronic and in certain cases paper-based records of the infants' development;
- he/she is open-minded and is open to changes occurring in his/her professional environment.
