- select the switching device, connect it, set its operating parameters and control it;
- install and commission industrial distribution equipment in accordance with drawings and in compliance with the electric shock protection and safety technology requirements;
- install engine control equipment and frequency converters according to the technical specifications;
- carry out pre-commissioning and operational tests of electrical machines and industrial distribution systems on the basis of documentation.
