3. PROFILE OF SKILLS AND COMPETENCES

- plan the execution of dentistry tasks and carry out the examination of the oral cavity of patients in the course of their work;
- plan and perform screening tests used in oral medicine;
- develop personalised prevention protocols for patients' oral health;
- organise and participate in health promotion events and screening programmes;
- apply, define and evaluate oral hygiene indices and record them digitally in specialised dental software;
- monitor patients' condition, changes in their level of pain and suggest solutions to their problems;
- apply groove sealing to patients according to protocol;
- plan and carry out the polishing and finishing of fillings, select the appropriate tools for the treatment;
- take impressions of patients' oral cavity for the procedures;
- prepare temporary crowns and bridges for patients on the dentist's instructions;
- plan and professionally inform patients about whitening procedures and provide them with advice on post-treatment care and lifestyle;
- accurately carry out teeth whitening procedures and apply various scale removal protocols;
- plan fluoride prophylaxis and apply the protocols related to the scope of the activity;
- prepare patients psychologically and somatically for dental treatment and participate in the care of patients following treatment by choosing the appropriate method;
- plan the microbiological and saliva tests to be carried out in the practice, and select the appropriate dental instruments;
- recognise dental erosion on teeth, plan oral hygiene treatment, plan and deliver oral hygiene lectures, demonstrate and teach methods of care and cleaning of dental prostheses, use personalised communication strategies appropriate to the target group;
- pre-plan and provide nutritional advice on dental problems;
- design oral hygiene treatments for different target groups and people with systemic diseases;
- provide dental health care lectures for patients with braces and fixed prostheses;
- perform health education and oral hygiene tasks in health, social and educational institutions, for healthy and sick adults and children, for bedridden patients and those confined to their homes;
- continuously extend their professional knowledge by attending professional conferences and training courses;
- treat and store municipal and hazardous waste generated in the course of their work in accordance with the regulations;
- use protective equipment in accordance with regulations;
- prepare equipment and materials for the appropriate sterilisation procedure, as well as handle and store sterile materials according to the rules;
- provide basic first aid.
